

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.appletonnorthlightningfootball.com/lightninggridironclub>, and The Lightning Gridiron Club and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Lightning Gridiron Club include <https://www.appletonnorthlightningfootball.com/lightninggridironclub> and LGC. The LGC website is a High School Football Club Information site. By using the LGC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, LGC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase LGC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Automatically Collected Information

Security of your Personal Information

- SSL Protocol

 - Comply with the California Electronic Communications Privacy Act;
 - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
